



### Content Area Summary Report

- Log into **DRC INSIGHT** at <https://ga.drccdirect.com/>.
- Choose **Interactive Reports**.
- Choose the **Content Area Summary** tab.
- Select the **Administration Window, Year, School(s), Course or Content Area** and click, **Go**.
  - Note that you will need to make at least one selection for every prefilter.



- On the left, charts show district-level achievement in comparison to the State and RESA (if applicable). On the right, the same types of charts show achievement for the schools that were selected. This view provides a quick visual of your district and school achievement.



- Next is a table view of the same information. There is no suppression for summary results for groups fewer than 15. The note above each display reminds users to refrain from publicly distributing results for groups comprised of fewer than 15 students, as required by FERPA.
