Assessment Update

Significant Medical Emergencies Guidance

In the event of a significant medical emergency, System Test Coordinators (STCs) must prepare a Testing Irregularity Form (TIF) in the MyGaDOE Portal to include all related documentation for review by the Office of Assessment & Accountability. Following that review, guidance and/or coding will be provided to the STC with next steps. Keep in mind that STCs must follow all guidance related to Hospital Homebound services and make-up testing as found in the <u>Student Assessment Handbook</u>.

STCs may make a significant medical emergency submission during the Spring 2024 Georgia Milestones (EOG and EOC), and GAA 2.0 administrations.

Note: Submission of a significant medical emergency is considered documentation of a student's non-participation for CCRPI. Any medical emergencies must be submitted in the MyGaDOE Portal TIF and coded in DRC INSIGHT, if applicable, prior to the closing of the state window. Medical emergency is no longer a non-participation reason in the CCRPI Non-Participation Application.

STCs are encouraged to review guidance in the *Medical Emergencies* in *Participation Rate Calculations* document on the <u>CCRPI Resources</u> for <u>Educators</u> webpage.


Save Time! An Advantage of Student Achievement Predictions Using DRC BEACON

Have you ever thought about how the predictive score from DRC BEACON to the Georgia Milestones assessment supports and informs classroom and/or school planning?

DRC BEACON saves educators and students time, and the predictions to Georgia Milestones are demonstrably accurate.

- Student achievement on BEACON allows for reporting of a predicted student achievement on the end-of-year Georgia Milestones assessment.
- The predicted Georgia Milestones score is based on the student's BEACON achievement in a given season of the school year; DRC has built three predictive relationships between Georgia Milestones end-of-year achievement based on when the BEACON tests were taken (i.e., the "seasons").
- BEACON performance levels are focused around the target of grade-level proficiency and progress, based on the premise that throughout the year, students are engaged in learning and are working their way towards being on-track for proficiency on Georgia academic content standards by year's end.
- The prediction appears on the Individual Student Report (ISR) as PROJECTED PERFORMANCE on the spring Georgia Milestones assessment.
- The math prediction to the Georgia Milestones assessment will not be reported this school year due

to standard setting, and that section will note that "Math predictive scores are not available for the 2023-2024 school year."

Teacher planning time and student learning time are two incredibly valuable resources. Using BEACON as a part of formative instructional practice or a benchmark interim assessment lets educators 'connect the dots' to inform planning and teaching practices. Using that data can improve student learning outcomes, and reduces the time lost to trying to understand status on state standards. That matters!

Georgia districts conducting their own studies of BEACON correlations have found the results to be highly correlated. That *also* matters, since that level of reliability allows educators to trust that the data will be useful enough to potentially reduce other testing and stop double assessing students on the same material for the same purpose. That makes the BEACON results truly actionable, providing useful, individual student predictive information.

It is important to note:

- These are projections of likely year-end achievement.
- There are other variables that can impact the prediction of spring Georgia Milestones achievement from earlier administrations of BEACON, such as interventions, rapid student learning progress, and more. This is a good thing!
- Student learning progression/growth is individualized and context dependent – with parents, teachers, and schools impacting student performance.
- A single testing event on a single day is just one piece of information about student achievement.
 Consider how this information aligns (or doesn't) with other data.

 Assessment results should not replace teachers' judgments but corroborate observations.

BEACON results are technically sound, reliable, valid, fair to all students and helpful to educators. The tight alignment to Georgia content standards and Georgia districts' scope and sequence documents means the predictive score saves both educators and students valuable time — a true DRC BEACON advantage.

End-of-Year Activities

The 2024 DRC BEACON testing window closes on Sunday, June 30. Before this date, districts should ensure all testing is complete and export all reports. The system will reopen on Thursday, August 1, for the 2024-2025 school year.

GKIDS 2.0 and GKIDS Readiness Check

The GKIDS ELA exemption is approved and can be used by schools as needed. Students who take a universal reading or dyslexia screener as specified are exempt from the requirement of taking the ELA domain of GKIDS. There is no exemption from the other required GKIDS domains (Mathematics, Approaches to Learning, Personal and Social Development). All schools should have most student performance data entered in the platform for the main GKIDS 2.0 assessment.

The April training webinar will provide an overview of which reports can be generated to assess the end-of-year performance for schools and districts. Teachers are responsible for generating and archiving the end of year individual student reports.

The roster upload process for the 2024-2025 school year will be in the .CSV format only. The SIS contact should be informed of this change. The advantages of the new format are as follows:

- the automatic creation of the teacher accounts so administrators do not have to manually enter the teacher names and email addresses.
- the automatic matching of teachers with students.
 This ensures the students are loaded directly to the specific teacher accounts instead of the teacher having to search for each student manually using a GTID number.
- · a simpler file and layout with less room for error.
- easier integration with Microsoft Excel.

WIDA ACCESS

As we approach the end of this testing cycle, it is essential to address any missing materials promptly. DRC will provide an initial **Missing Materials Report** to the GaDOE this month. This report highlights secure test materials that STCs have not returned to DRC.

District Expectations:

- If your district appears in the report, please ensure timely completion of a TIF.
- STCs must list all missing materials in the Accountability Form. You can find the form in WIDA AMS under Materials > Accountability Form.
- STCs must account for the final disposition of all secure materials.

Data Validation Process:

As part of the WIDA ACCESS assessment, it is crucial that you engage in the Data Validation process. This step allows you to meticulously review student data, focusing on demographics, accommodations, and other critical test information. By identifying potential errors early, you can ensure accurate reporting before DRC publishes final reports.

Moreover, during this phase, both STCs and members of your district teams should collaborate closely. Specifically, take the time to match split test records accurately. Additionally, address any unclaimed test records within the AMS. This collaborative effort ensures data integrity.

Georgia Alternate Assessment 2.0 (GAA 2.0)

As we gear up for the upcoming testing season, let's revisit some critical points from your Pre-Administration Training. These reminders will help ensure a smooth testing process and maintain the integrity of our assessments.

Stopping Rule

Test Examiners play a crucial role in administering tests to our students. They must follow the prescribed script for all students. Here are the key points regarding the Stopping Rule:

- Opportunity: Each student must have an opportunity to attempt each content area test.
- Communication System: When administering the
 assessment to students who do not have an
 established communication system, Test Examiners
 should administer all parts of the first two tasks. If
 these students do not respond during this process,
 the Test Examiner may stop testing for the current
 content area and seek approval from the School Test
 Coordinator (SchTC) to stop testing.
- Behavior, Frustration, and Knowledge: The Stopping Rule should not be applied based on a student's behavior, frustration level, or knowledge of the content. All students must be allowed to take each content area test.

Transfers

When a student transfers out of the district, follow these steps:

- The STC of the receiving district must submit the Student Transfer Form in Student Management.
- DRC Customer Support will address transfer requests promptly and notify the receiving district's STC upon completion.
- The receiving district's STC must provide new testing material to the transferring student.

Reopening Tests

Once a test has been submitted, it cannot be reopened. Therefore, Test Examiners should verify that all items have been completed accurately before submitting the test. Attention to detail is crucial to maintaining the validity of our assessments.

Returning Materials

STCs are responsible for tracking and returning all secure materials. Here's what you need to do:

- An Excel file version of the Security Checklist will be posted to Report Delivery in Interactive Reporting in INSIGHT.
- Use the Security Checklist to track the return of materials within your district.
- Return secure materials to the vendor in the original DRC boxes.
- Affix one white DRC Return Box label and one UPS Return label on the top of each box being shipped to DRC.
- Follow the return instructions specified on the Materials Return Poster diligently.

New Users and Password Resets

Reporting requires the creation of new teacher and school administrator users in DRC INSIGHT. When new users are created or when a user needs to reset their passwords, an email is sent to the user automatically from DRC. To ensure that the emails make it to your users, districts should ensure the following.

Make sure that emails from no-reply@datarecognitioncorp.com are not flagged as junk/spam or sent into quarantine.

The automatically generated password reset emails are long. Please ensure email servers are not blocking long URLs.

Allowlist the following on your network:


If all of this has been done, and the user has not received an email with their password, they should click on "Forgot your Password" so that a new password is generated and sent.

Please share the following reminders with your Technology Directors.

BACKGROUND SOFTWARE

- DRC INSIGHT software does not turn off software running in the background of a test device.
- Recommend temporarily disabling some software before testing, for example:
 - Automatic Operating System Updates and Other Background Processes.
 - Intelligent personal assistant (IPA) software (e.g., Siri, Cortana).
 - Collaboration tools e.g., Zoom, Microsoft Teams, Google Chat, Google Meet.
 - Microsoft Game Bar.

KEYBOARD SETTINGS


- You must set Chrome OS Devices to US English Keyboard to display quotation marks and apostrophes.
- Allow prior keyboard settings to be cleared from the cache <u>at least a week before</u> testing either:
 - Set device to "US English Keyboard" (Using Ctrl + Shift + Spacebar, toggle through the keyboard types until US English Keyboard displays).
 - Consider removing all keyboards except US English Keyboard.
- iPads must have Smart Punctuation disabled to allow quotation marks and apostrophes to display.


TEST CONTENT




Managing Users for Georgia Milestones Interactive Reporting

Interactive Reporting requires User Accounts for Teachers and Administrators to be active in the system. System Administrators will upload the user information in the Batch User Upload File and identify them as School or Teacher Roles and then they can be mass assigned a Permission-set.

MSU and Accommodation File Uploads

Did you know that STCs can download an error report to better understand existing errors on their MSU and Accommodation upload files? This feature, shown below, is available in *Import Management* and will include a list of all errors received when an MSU or Accommodation file is uploaded to DRC INSIGHT. STCs and SIS Data Coordinators can use this information to clean up their data and improve future upload processes.

Student Growth 2023-2024

Student Growth Percentiles (SGPs) and growth targets will be calculated and reported for the 2023-2024 school year. SGPs describe student growth from a past year to the current year by comparing student test performance to that of academically similar students. Growth targets estimate the level of growth a student may need in the following year to perform at the next achievement level. Students, teachers, and parents can use SGPs, growth targets, and achievement results to better understand student academic performance and what it will take to improve it. For general information about SGPs and growth targets, visit the Georgia Student Growth Model website. A few details about SGPs and growth targets for 2023-2024 are listed below.

 SGPs for EOG will be calculated for the ELA and Mathematics content areas. SGPs for Algebra:

- Concepts and Connections will be calculated following standard setting. SGPs for American Literature and Composition will not be calculated.
- Growth targets will be calculated for EOG in ELA grades 4-7 only.
- SGPs and growth targets will appear on the final ISRs and in the final system level data files for each Georgia Milestones administration.
- SGPs will be calculated for students whose current Georgia Milestones score can be matched to a prior year's Georgia Milestones score in the same content area. This match will be done using the final assessment files using student names and GTIDs as the match fields.

Interactive Reporting and Summary Results Embargo

Final reporting begins when summary results are released to districts on the Interactive Reporting System. GaDOE understands that districts need to have time to view their summary results, plan next steps for instruction, and construct a narrative about student achievement that they can share with the public. GaDOE takes this very seriously and does not "wait" to release summary scores to districts. Likewise, GaDOE needs time to create supplemental reports and prepare media releases. The window of time when summary results are available to districts, but not the public, is called the *embargo period*. During the embargo period, summary information shall not be discussed at public meetings or released to the public/media – it can only be used internally.

A common source of confusion is about which reports are subject to the embargo. The embargo applies to summary reports only. Individual reports, such as class rosters and preliminary and final ISRs, are not subject to the embargo and can be shared with students, parents, teachers, and staff as soon as they are made available, in accordance with FERPA. Although the static PDF summary reports are now retired, the summary report embargo is still applicable to the summary reports available on DRC's Interactive Reporting System. Again, during the embargo period, districts can use summary results internally for analysis and planning, but they cannot release them publicly. STCs are encouraged to remind district and school staff about appropriate uses of

embargoed summary data. GaDOE will communicate the date for the public release to districts as soon as it is available.

State Literacy Metric

In November 2023, the State Board of Education adopted a state literacy metric that fulfills the requirements of the Georgia Early Literacy Act (2023 HB 538). The adopted state literacy metric is consistent with existing cut scores used to classify student Lexile measures into meaningful achievement groupings since 2015. However, instead of using three categories to classify student reading achievement (Below Grade Level, Within Grade Level, Above Grade Level), it uses four categories (Below Grade Level, Grade Level, Grade

Level Plus, and Above Grade Level). Specifically, the new State Literacy Metric separates the existing Within Grade Level category into two categories: Grade Level and Grade Level Plus. Please note that the State Literacy Metric will *not* replace the MetaMetrics' Grade Level categories on Georgia Milestones reports, including the ISR during the 2023-2024 school year.

As a reminder, high schools selected for grade 12 assessments will also participate in the High School Transcript Study (HSTS), which involves the collection of student transcripts and course catalogs. This information will be used to examine course-taking patterns of students and relate those patterns to educational achievement and NAEP assessment data. First conducted in 1987, HSTS has been gathering data on course-taking for more than 3 decades, with the most recent collection in 2019.

Districts with grade 12 schools that tested should have submitted the requested years of course catalogs. The transcripts for grade 12 students who tested should be submitted during the summer.

Accountability Update

The CCRPI Live Data Verification tool is now available in the MyGaDOE Portal with demographic and attendance data. The tool provides summary data from Student Record that updates nightly as your district updates the data. This tool will assist district staff and principals in verifying the accuracy of the data submitted in Student Record and Student Class before the data collections close.
